2. The contract of appointment may be terminated by either side by giving 3 months' notice or by paying the contractual remuneration in lieu of notice period, if the circumstances so warrant.

V. GENERAL INSTRUCTIONS:

1. Candidates who have been shortlisted only will be called for interview.
2. Internal candidates working in BMRCL who are desirous to apply for the post advertised should have completed a minimum of 3-years of relevant experience in the immediate lower post/Grade and should submit through proper channel.
3. Post-qualification experience will only be considered. Mere possession of minimum experience does not confer any right to be called for interview / selection.
4. Any canvassing by or on behalf of the candidates or to bring political or other outside influence with regard to selection/appointment shall be a disqualification.
5. Selection will be made through interview by a Committee constituted by the competent authority.
6. Knowledge of Kannada will be given preference.
7. Documents in support of qualification and relevant experience shall be sent along with the application. Non-submission of documents along with the application will lead to rejection of application at any stage during the process of recruitment.
