

## **Notification for NABARD Student Internship Scheme (SIS) 2026-27**

NABARD invites applications for Student Internship Scheme 2026-27 from students pursuing their post-graduate degree/PGDM (having completed/completing 1<sup>st</sup> year) or 5 years integrated courses (having completed/completing 4<sup>th</sup> year) from institute/university.

The objective of the Scheme is to assign short term tasks/projects/studies useful and relevant to NABARD, to talented students pursuing post-graduate degree (completing/completed first year) in Agriculture and allied disciplines (Veterinary, Fisheries, etc.), Agri-business, Economics, Agri-economics, Social Sciences and Management from Institutes/ Universities of repute or students pursuing 5 year integrated courses completing/completed 4<sup>th</sup> year of their course. Indian students studying abroad are also eligible for SIS 2026-27.

The scheme is expected to provide valuable feedback with a fresh perspective through studies/projects undertaken by the students on themes of interest to NABARD.

### **(A) Total Seats**

Total number of seats for NABARD SIS 2026-27 is **39** (34 seats for Regional Offices (RO)/ Training Establishment (TE) and 05 seats for Head Office). Each RO/TE will be allocated only 01 seat under SIS 2026-27. Detailed break up of seats is given in Annexure I.

### **(B) Broad Themes/Areas**

The broad objective of SIS 2026-27 will be to examine topics of contemporary relevance as well as to assess/gauge the impact of various NABARD interventions at the ground level. The SIS 2026-27 will also serve as an exercise for documentation of success stories of NABARD's projects/ programmes/ schemes/ activities at the field level.

To ensure that we have a decent number of reports on a particular topic so that we can draw reasonable insights, all interns selected under SIS 2026-27 will be required to study one of the following five NABARD interventions only:

**a. Women Farmers in Indian Agriculture: Opportunities, Issues, and Way Forward**

**b. Role of Computerization of PACS in Enhancing their Operational Efficiency**

**c. Impact assessment of FPOs promoted under NABARD, their Sustainability and Market Linkage**

**d. Impact of GI Registration - Post registration opportunities and challenges**

**e. Rural women Entrepreneurs - Migrating from SHG Members to individual entrepreneur - Challenges and opportunities**

### **(C) Eligibility**

- i. Students pursuing post-graduate degree (having completed/completing first year) in Agriculture and allied disciplines (Veterinary, Fisheries, etc.), Agribusiness, Economics, Agri-economics, Social Sciences and Management from Institutes/ Universities of repute or students pursuing 5 years integrated courses completed/completing 4<sup>th</sup> year of their course. Indian students studying abroad are also eligible for SIS 2026-27.
- ii. Students applying for **internship in a particular State (RO/ TE) must be either pursuing their degree from that State or they must belong to that State (ordinarily resident of the State).**
- iii. However, seats in Head Office, Mumbai are open to applications from students across the country.

### **(D) Selection Process**

- i. The applicants for the scheme will be shortlisted for interview on the basis of weighted score system (**based on marks in 10th, 12th and Graduation**).
- ii. The **final** selection of the students for the internship scheme will be **solely on the basis of the interview performance.**

### (G) Duration of Internship

The duration of the internship will be a minimum of 8 weeks and a maximum period of 12 weeks.

### (H) Financial Support

The financial benefits for implementation of the scheme are as under:

### **(I) Oath of Secrecy by Student**

The students shall also give a declaration that they will maintain complete secrecy and shall not use any information of confidential nature for any other purpose that might come to their knowledge during the period of assignment under the Scheme.

### **(J) Release of Stipend & Other Allowances**

- i. The monetary benefits such as stipend, field allowance, etc. may be released to the students on satisfactory completion of the projects.
- ii. The claim for stipend is to be submitted in the prescribed format.
